

Terms and Conditions – RACQ International Women's Day Fun Run Race Bib Prize Promotion

1. Entry into the RACQ International Womens' Day Fun Run 2019 (IWDFR) Race Bib Prize ("**Promotion**") is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
2. Entries for the Promotion commence on 00:01hrs AEST Sunday 03 March 2019 and close at 09:00hrs AEST Sunday 03 March 2019 ("**Promotion Period**").
3. Entry is open to IWDFR participants ("**Entrants**").
4. Directors, officers, management, employees and other staff (and the immediate families of directors, officers, management, employees and other staff) of Mater Foundation and their related bodies corporate and agents are ineligible to enter.
5. Directors, officers, management, employees and other staff (and the immediate families of directors, officers, management, employees and other staff) of The Royal Automobile Club of Queensland Limited (RACQ) and their related bodies corporate and agents are ineligible to enter.
6. The Promoter reserves the right in their sole discretion to disqualify any individual who the Promoter have reason to believe breached any of these conditions, or engaged in any unlawful or otherwise improper misconduct calculated to jeopardise the fair and proper conduct of the competition.  - o Remove the RACQ tear off section from their race bib; and
 - o Place the tear off section in the RACQ barrel located at the RACQ stand

10. The total prize pool is valued at \$1,000
11. The Major Prize Winner will receive:
 - 11.1. A \$1,000.00 eftpos voucher, which expires 12 months after the winner has activated the card. Instructions on how to activate the card will be provided
12. The Major Prize draw will take place at 09:30 AEST on Sunday 3 March 2019 on stage at the Cultural Forecourt, Southbank Parklands. The first valid entry drawn will be the winner.
13. If the Major Prize Winner is not present at the time of the draw, and therefore unable to claim their prize, the Major Prize draw will be redrawn until a winner is identified.
14. The Major Prize Winner will be advised at the event and their name will be published on www.womensdayfunrun.com.au
15. The Major Prize Winner will receive their prize via at the event.
16. Entries must be received by the Promoters within the Promotion Period. Entries are deemed to be received upon the bib tear off being placed in the barrel. Records of the Promoters are final.

- 17.1. The value of the prize pool is accurate at the date of commencement of the Promotion Period. The Promoter accepts no responsibility for any variation in the value of the Prize after that date.
- 17.2. The Prize cannot be transferred, exchanged or redeemed for cash.
- 17.3. The Promoter's decision is final and no correspondence will be entered into, including in the event of a dispute.
- 17.4. If a purchase exceeds the face value of the voucher, you must make up the difference with another payment method; you are liable for all transactions on your voucher.
- 17.5. If for any reason the prize is not used by the expiry date identified on the voucher, the prize, or any remaining portion of the prize will be forfeited.
- 17.6. The Promoter accepts no responsibility for lost or stolen vouchers.
