

Terms and Conditions - RACQ International Women's Day Fun Run SMS Challenge Promotion

1. Entry into the SMS Challenge ("**Promotion**") is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
2. Entries for the Promotion commence on 00:01hrs Wednesday 20 February 2019 and close at 23:59hrs Thursday 21 February 2019 ("**Promotion Period**").
3. Entry is open to registered RACQ International Women's Day Fun Run 2018 participants ("**Entrants**").
4. To enter, Entrants must receive donations totalling a minimum of \$20 (twenty dollars) to their individual fundraising page during the Promotion Period. Each donation totalling \$20 will be a be classed as valid entry. Donations can be made by searching a name via the RACQ International Women's Day Fun Run website www.womensdayfunrun.com.au
5. Each valid entry received during the Promotion Period will be placed in the Major Prize Draw.
6. There is a total of One (1) major prize winner ("**Major Prize Winner**")
7. The total prize pool is valued at \$2000
8. The Major Prize Winner will receive:
 - 8.1. An Executive Cleaner for 3 months provided by Springmount Services Pty Ltd.
 - 8.1.1. Cleaning service includes (with or without winner direction):
 - 8.1.2. clean and dust all surfaces;
 - 8.1.3. clean mirrors;

 - 8.1.5. mop and sanitise all floors;
